During the month of November 2011 the city of Moorhead held elections for spots on the City Council, and the North Dakota Legislature held a special session. LWVRRV sponsored a Moorhead candidates' forum and a citizens' information forum about the special session featuring local ND legislators.

There will be a primary election in North Dakota on June 12, 2012 along with Fargo city and Cass County elections. ## News from the LWVUS

### ■ Elections: Voter protection results mixed

In this week's elections across the country, voter protection saw a mixed bag of results, including a win and a loss. WIN: In Maine voters rejected the new law that did away with Election Day registration. Congratulations and big thanks to the LWV of Maine (and its coalition partners) for initiating and securing a "Citizens' Veto!" LOSS: In Mississippi, voters approved voter photo ID. These mixed results emphasize the urgent need to continue defending our democracy at home.

### ■ Redistricting: North Carolina League files suit against state plans

The LWVNC joined with partners, including the NAACP, Democracy NC, the Randolph Institute and 27 individual voters, last week in filing a high-profile lawsuit against the state's approved House, Senate and congressional redistricting plans. The lawsuit claims legislators blatantly and illegally manipulated communities based on race and political makeup to achieve partisan gains.

### ■ Redistricting: Federal Court sides with league and others on Texas Plans

Following months of outcry by the League and other key groups that the Texas redistricting plans blatantly violate Section 5 of the Voting Rights Act and intentionally

dilute the power of minority voters, the U.S. District Court in Washington, DC, this week denied fast-track approval of the state's congressional, House and Senate redistricting plans. This move ensures a federal trial over the widely challenged plans and will require a San Antonio judge to craft new plans for use during the 2012 elections. Congratulations to the LWVTX and all the others who worked to block the implementation of these discriminatory maps!

### ■ Letter from the President of LWVUS opposing termination of the Election Assistance Commission

November 2, 2011

TO: Members of the U.S. Senate

The League of Women Voters urges you to oppose efforts to terminate the Election Assistance Commission as part of the appropriations process. Instead of eliminating the EAC, we believe that Congress should strengthen the commission and expand its responsibilities. The League believes that elections are fundamental to a functioning democracy and that every effort should be made to elevate their administration to the highest importance. Congress should not turn its back on federal efforts to ensure election integrity, improve voter access to the polls, and improve election systems. The value of the EAC far outweighs its monetary costs; in fact, the costs of poorly run elections are intolerable. It is time for election administration to move into the 21st Century, not back toward the 19th.

Unfortunately, elections in our country are still not well-administered, and we are concerned that many states and localities are not doing a good job ensuring federally-protected voting rights. For example, a GAO report on the 2008 election said that there are significant problems for persons with disabilities in gaining access to the polls. Physical barriers remain in far too many cases. In fact, 31 states reported that ensuring polling place accessibility was "challenging."

There are many other areas of election administration that cause concern, including statewide voter registration lists, provisional balloting, list cleaning, voting machines and tabulating, access to registration, and meeting voter information needs. In addition, there are critical questions that must be addressed about the application of new technologies like the Internet to the voting and registration processes. Each of these areas would benefit from additional study, data gathering and information sharing among election officials at every level, the public, and concerned organizations.

With these continuing problems, now is certainly not the time to abolish the only federal agency that devotes its full resources and attention to improving our elections. Let us not go back to the 2000 election but go forward, improving each election over the last. We know what needs to be done; now let us devote the resources to what should be done.

## North Dakota's public policy on children's issues

North Dakota has some incredible needs for our children in spite of our flush general funds. Currently, North Dakota:

Provides the **lowest level of health care coverage in the nation** for children living in low-income working families.

Is the **only state in the nation that does not provide any general fund money** to Head Start, even though 1,300 children are eligible but unable to access this successful program.

North Dakota ranks 49<sup>th</sup> in the nation in terms of federal and state spending on childcare. (2009)

North Dakota is 50<sup>th</sup> in the nation on total child care expenditures. (2009)

## History notes—100 years ago

The first International Women's Day on March 8 produces rallies in Austria, Denmark, Germany, and Switzerland to protest lack of representation of women in trade unions.

New York's Triangle Square Shirtwaist Factory burns on March 25. Killed are 146 people, most of them young sweatshop seamstresses who were unable to escape because the factory owner locked all exits so employees could not steal inventory. 500 women and 50 men worked from 7:30 am to 6 pm, mostly for \$6-\$8 per week.

Social worker Gertrude Barnum works to raise funds for the International Ladies' Garment Workers' Union over the next 5 years.
