In Memorium: Carolyn Bowe

The presence of Carolyn Bowe, a regular attendee of First Friday meetings, will surely be missed. She died on Saturday, October 9, in the palliative care unit of Meritcare Hospital ending a ten month struggle against pancreatic cancer.

Carolyn's contributions to the local and state Leagues are formidable. Having served as President of the then Fargo League, she became North Dakota State League President in the early seventies. It was the time when the passage of the Equal Rights Amendment to the national constitution was controversial.

Through the years Carolyn remained very active in the League--working on Voter's Guides to election issues and editing *The Voter* for many years. These projects benefited from fact that she was once a professional journalist. Most recently, Carolyn was a local board member when the LWVRRV was organized.

In addition to League activity, Carolyn was at various times a member of the North Dakota Humanities Commission, the Tri-College Speakers Bureau and the North Dakota Commission on the Status of Women, among other organizations.

Travel was of great interest to Carolyn and her husband, David, following their retirement as owners of Pella Products in Fargo. They visited Cuba just last year and China a few years earlier. Her observations were always insightful.

Carolyn was a concerned and stimulating woman and a wonderful role model for women everywhere.

Lakes Area LWV formed

By mid-September they had held a primary candidate forum for Becker County Commissioner races, organized voter registration at each of the high schools in the county, and distributed membership brochures to people interested in LWV.

Consensus meeting to be held in January

In 2003 LWV-Minnesota adopted a new study that would look at the comparative merit of the most frequently mentioned alternative voting systems. LWVRRV will be holding a consensus meeting on Saturday, January 15, 2005 to provide an opportunity for our members to learn the facts and issues involved in our current voting method and four alternative methods.

First Fridays

At the September meeting, Lois Altenburg spoke about the history of the League of Women Voters, starting with its beginnings as a part of the women's suffrage movement. Many of those attending the meeting told of how they became interested in League, and what their membership has meant to them.

In October, Cass County Auditor Michael Montplaisir spoke about the challenges and intricacies of creating the ballots that are used in primary & general elections. The primary ballots are particularly difficult, since there are so many nonpartisan city and township races on the same ballots as the partisan primary races. Cass County had to produce 170 different ballots for this June's primary election. For the November general election, 73 different types of ballots have been created.

Nov. 2, 2004 - General Election Ballot Initiated Ordinances on Smoking

City of Fargo Initiated Ordinances #1, #2, and #3 all pertain to the regulation of smoking in public places within the city.

You may vote yes or no on all three of these ordinances. In order for any one of these ordinances to be enacted, it must receive more than 50% yes votes.

If none of these ordinances receives a majority of yes votes, there will be no increased city regulation of smoking in public places.

Since these ordinances contain conflicting provisions, only one of them can ultimately be enacted. So, in the event that two or more of these ordinances gets more than 50% yes votes, the one that receives the highest number of yes votes will be enacted.

Initiated Ordinance #1

If this ordinance is enacted, smoking will be banned in all indoor public areas & workplaces except for all truck stops & the following bars and restaurants:

Initiated Ordinance #2

If this ordinance is enacted, smoking will be banned in all indoor public areas & workplaces except designated smoking areas at trucks stops and enclosed (floor-to-ceiling walls & solid doors) bars where liquor is served and persons under age 21 are not allowed entrance.

Initiated Ordinance #3

If this ordinance is enacted, smoking will be banned in all indoor public areas & workplaces except for the tobacco bar known as JT Cigarro

Voter's Guide

November 2, 2004 - General Election Ballot Initiated Ordinances on Smoking

City of West Fargo Initiated Ordinances #1 and #2 both pertain to the regulation of smoking in public places within the city.

You may vote yes or no on both of these ordinances. In order for either one of these to be enacted, it must receive more than 50% yes votes. If neither of these ordinances receives a majority of yes votes, there will be no increased city regulation of smoking in public places.

Since these ordinances contain contradictory provisions, only one of them can ultimately be enacted. So, in the event that both of these ordinances gets more than 50% yes votes, the one that receives the highest number of yes votes will be enacted.

Initiated Ordinance #1

If this ordinance is enacted, smoking will be banned in all indoor public areas & workplaces except for the following bars:

- Bordertown Bar & Grill
- Frontier
- M&J
- O'Leary's
- Silver Dollar
- Town Hall Bar

Initiated Ordinance #2

If this ordinance is enacted, smoking will be banned in all indoor public areas & workplaces except for retail tobacco stores.
